# **RESOLUTION NO. 011-2019**

VILLAGE BOARD SUPPORT OF PUBLIC PROJECT BY DELAWARE COUNTY INCLUDING THE ACQUISITION OF CERTAIN MINOR EASEMENTS AND FEE ACQUISITIONS.

Motion By: Larry Reilly; Seconded By: Dan Halpren.

**WHEREAS**, the Delaware County Department of Public Works ("DPW") is engaged in a certain public use project to replace Bridge 80 (Bridge Street over the Bush Kill) located in the Village of Fleischmanns ("Project"), Town of Middletown, Delaware County, New York;

**WHEREAS**, the proposed new bridge would replace the prior vehicular bridge that was washed out in the heavy rains and flooding experienced during Hurricane Irene, which occurred August 26 to September 5, 2011, and was declared a major disaster by President Barack H. Obama on August 31, 2011 (FEMA 4020-DR-NY);

**WHEREAS**, the Village Board of Fleischmanns is always desirous to improve the local community and quality of life within the Village of Fleischmanns;

**WHEREAS**, the Project requires the County of Delaware (the "County") to acquire minor easements and/or fee acquisitions of real property to accommodate the Project, as detailed on the Project maps entitled *Delaware County Acquisition Map*, *Bridge Street*, *Pedestrian Bridge*, *Over Bush Kill*, Map Nos. 1 – 5 (23 pages) ("Acquisition Map");

**WHEREAS**, based upon the Project maps identified above, the County has determined that the contemplated acquisitions are all minor in nature, only affecting small portions of individual properties and constitute minor amounts of land and land interests, and therefore any of the individual acquisitions by Eminent Domain would be

de minimis in nature so that the public interests will not be prejudiced by the acquisition of those property interests for construction of the Project;

**WHEREAS**, the County of Delaware has determined that the Project is in the best interest of the County of Delaware and its residents and, as a result, that the contemplated acquisitions are in the best interests of the health, safety and welfare of the County and its residents, as it is in the public's best interest that the Project be properly constructed and maintained;

WHEREAS, by Village of Fleischmanns Board Resolution dated 13 May 2013, the Village has decided that the construction of a pedestrian bridge at Bridge Street Bridge and Lake Switzerland are critical to the economic sustainability of the Village and to the implementation of the Village's master plan, and the Village will assume complete ownership and maintenance responsibilities for both structures after the County reconstructs the two structures (Lake Switzerland pedestrian bridge already having been completed, and;

**WHEREAS**, the Village of Fleischmanns is in full support of the Project and the County's efforts and now seeks to endorse the County's efforts by formal resolution;

**NOW THEREFORE, BE IT RESOLVED** that the Village Board of the Village of Fleischmanns hereby states its support of the Project for replacement of the Bridge 80 (Bridge Street over the Bush Kill), including the acquisition of certain minor easements and fee acquisitions, as identified in the Acquisition Map, as deemed necessary by the County to accomplish the Project.

Treasurers report through August 31, 2019 submitted by Village Treasurer Winifred Zubin noting 3<sup>nd</sup> month of the Fiscal Year and operating normally with collections slightly lower than prior year: Taxes 83% versus 86%; Water 23% versus 20%, Sewer 73% versus 88% at this same time.

### Financing Options for Village Pool, Lake Street Embankment, and DPW Truck Replacement

Village Treasurer Winifred Zubin outlined financing options:

### **DECISIONS NEEDED**

Significant non-recurring, expenditures have been authorized and may exceed available general fund cash in the absence of external financing.

### Assumptions

- 1. Current year general fund budget will meet the approved budget for revenues & expenditures +/- 10%. Ten % of current year budget is \$32,000.
- 2. Costs
  - Pool building contract is \$287,000
  - Lake Street embankment estimate \$93,000
  - Village truck cost estimate \$75,000
- 3. Timetable for reimbursement for pool from DASNY, and Homeland Security for Lake Street could be one year or more
- 4. General fund cash balance at 5/31/19 was \$348,943
- 5. Financing options
  - Approach Catskill Watershed Corporation (CWC) to issue Bond anticipation Note (BAN) for \$380,00 for both the pool and Lake Street combined. BANS with CWC are renewal yearly, with 0.00% interest, but with attorney's fees.
  - Seek commercial financing for Truck purchase: Town of Middletown recently committed to a \$75K callable note from NBT bank at 2.55%.
  - Utilize Chips money for a portion of the truck, confirmed as available and eligible expenditure totaling 47, 965
    - i. CHIPS 29,762
    - ii. EWR 18,203
  - Utilize existing cash flow and pray a lot
  - Not being considered
    - i. Borrowing from Fire Department Truck Reserve Fund, or Sewer fund

### **Existing BAN**

- 1. We have an existing BAN with a balance of \$300,540 which is renewal this month
  - a. This is financing a FEMA receivable for Irene disaster relief project worksheets
  - b. We have been offered two options to renew

- i. Pay off in three equal installments of \$100,181.91 beginning September 2019
- ii. Pay a minimum of \$1,364.38 in September 2019
