Mayor Fred Woller called the Special Meeting to order at 6:07 pm. Village Clerk took roll call: Fred Woller, Larry Reilly, Dan Halpren, Ben Fenton, and Jennifer Barrows were present. Deputy Mayor and Trustee Village Treasurer Winifred Zubin was present. Members of the public in attendance: Michael Martin of <u>The Mountain Eagle</u>, and Joseph Srp of Fleischmanns.

Mayor Fred opened the meeting with Organizational Appointments

Fred Woller made Motion to approve Appointment of Benjamin Leer to the Zoning Board of Appeals term expires Aug 27, 2025; seconded by Dan Halpren. All ayed; motion carried.

Old Business:

Fred noted Village Elections are tomorrow September 15, 2020 in the Skene Library from Noon to 9 pm. An Ipad located in Library or Village Clerk office for those wishing to complete The Census 2020. Deadline is Sept 30, 2020. Park is still closed due to health and safety risks for Bathrooms & Playgrounds. Pool construction completion still sometime in Nov 2020. Pool will be filled and tested in the Spring. Fleischmanns First pool house rehab is delayed due to the delay in the pool construction. On Sept 13 close to 30 people turned out for the Theater Cleanout Work party. It only took 1.5 hours and filled a dumpster and a pickup truck worth of refuse. Thank you to everyone who came out. Ellsworth Avenue grading is still pending Town of Middletown schedule.

Jennifer Barrows asked for a **Motion to approve Resolution 011-2020: Adoption of Fleischmanns Policy Manual dated September 14, 2020** which was considered last month. Motion made by Larry Reilly; seconded by Ben Fenton. Fred Woller-Aye; Larry-Reilly-Aye; Jennifer Barrows-Aye; Ben Fenton-Aye; Dan Halpren-Aye. Resolution 011-2020 adopted.

Mark Project Theater roof repair/replacement fundraising Larry Reilly noted that an update is expected by September 15, 2020

Ben Fenton noted the Kiosk RFP responses are due back at the end of the month.

NYSERDA Green Community – 5th Initiative – Charging Station project. Dan Halpren indicated waiting on electrician proposal. 200amp may be needed to bring into the parking lot. Ben Fenton recommended striping the parking lot while Larry Reilly noted the striping may reduce available parking spots.

New Business:

Wagner Ave Water Main break: Fred Woller noted the break was found within 2 hours. Parts to replace were on hand and HD Construction invoice was \$5,010 and John Blish at \$450.

Larry Reilly noted that the remediation plans have been submitted to the DEC for the Notice of Violations (NOV) the village received occurring from the July 19 and 29 sewer overflows due to wipes. Waiting on DEC response. Board may consider Housing Development Plan to address at developments. It's not just Fleischmanns; it's a worldwide issue. Upgrades may include chopper pumps but who is going to pay is still up in the air. Issue occurs generally within a three-month period.

Dan Halpren volunteered to interview village staff and document the Village of Fleischmanns Operational Plan in response to the new required New York State Pandemic Plan Elements which is due to the State by April 1, 2021.

Executive Session

At 6:32 pm Mayor Fred Woller closed the Public Meeting to enter Executive Session for the board to discuss legal matters. No actions were taken by the Board.

At 6:37 pm The Board returned and the Mayor reopened the Public Meeting. Mayor and Trustees were all present.

Winifred Zubin representing Fleischmanns First is looking for low cost, accessible, winter activities. If the Board has any issues please raise.

Joseph Srp of Fleischmanns asked for the reasons for the oil and stoning which causes a lot of dust near his home on the recently paved Wagner Ave. Fred Woller and Ben Fenton tried to explain that oil and stoning extends the life of non-state and county roads with limited traffic. Dust from the oil and stoning should subside in a few weeks.
