- 2. Motion to approve December 2, 2021 Trustee Meeting Minutes by Barrows, seconded by Cohen. All in favor.
- 3. Reports: Water/WWTP Dept Reports for December 2021 haven't been circulated yet, will approve at next meeting.
- 4. Motion to approve December 31, 2021 Financial Reports by Barrows, seconded by Cohen. All in favor.

5. Old Business:

- b. Craig Cherry has volunteered to maintain the Lake Street Bridge during the winter months so it can remain open for everyone to use and enjoy.
