A Public Hearing on NYC DEP - Acquisition and Access for Parcel 9316 ICO Grossman property was held on Monday, November 18, 2019 at 5:45 p.m. at the Skene Memorial Library, 1017 Main Street, Fleischmanns, New York.

Mayor Fred Woller called the Public Hearing to order at 5:51 pm and called Roll Call at 5:51 pm., present were Mayor Fred Woller, Trustees Dan Halpren, Ben Fenton, and John Granito. Trustee Larry Reilly was absent due to illness. Also, in attendance was Village Treasurer Winifred Zubin. Also present were Roy Todd, Calvin Wright, Geralyn Buckenberger, Chris Yagasits, Michael Martin of The Mountain Eagle, Marilyn Ringel, and Janet Becker.

Mayor Fred Woller opened the public hearing noting the NYC DEP intent to acquire and provide public access for the NYC DEP numbered parcel 9316 owned by Harriet Grossman and opened the floor to Public Comments. There being none, Mayor Woller closed the public hearing at 5:52 p.m.

The regular meeting of the Village of Fleischmanns Board of Trustees was held Monday, November 18, 2019 at 6:00 p.m. immediately following the Public Hearing at the Skene Memorial Library, 1017 Main Street, Fleischmanns, New York.

Mayor Fred Woller called the meeting to order at 6:01 pm and called Roll Call at 6:02 pm., Fred Woller, Dan Halpren, and Ben Fenton, and John Granito were present. Larry Reilly was absent. Also, in attendance was Village Treasurer Winifred Zubin and Deputy Clerk Paula DeSimone. Municipal Attorney Carey Wagner was also absent due to illness. Also present were Roy Todd, Calvin Wright, Geralyn Buckenberger, Chris Yagasits, , Michael Martin of The Mountain Eagle, Todd Pfleger, Marilyn Ringel, Janet Becker, and Jennifer Walsh.

Minutes

Fred Woller tabled the motion to accept the September 9, 2019 VB Regular Meeting Minutes at the request of the Village Clerk as the minutes are presently unaccounted for.

Motion to approve October 21, 2019 VB Regular Meeting Minutes made by Fred Woller; seconded by John Granito. All ayed; motion carried.

Motion to approve November 7, 2019 VB Special Meeting Minutes made by John Granito; seconded by Ben Fenton. All ayed; motion carried.

Water and Sewer Report – Jim Buchan back to work on a medically limited duty part time. Written water report provided. Paula DeSimone discussed Water Shutoff Notices to residents posted last Friday November 15, 2019 for 13 properties. Total owed is approximately \$19,000. Some property owners have contacted the office to work out a monthly payment plan. Collected \$3600 this week. Two accounts alone account for about \$6,000

Treasurers report

Treasurers report through October 31, 2019 submitted by Village Treasurer Winifred Zubin noting 5th month of the Fiscal Year. Proceeding with annual financial plan. Recommend communication to notify 7 property owners that village is prepared to proceed with foreclosure.

M-Ark Project Theatre Feasibility Report

Email dated 11/18/19 received from Peg Ellsworth indicates she was unable to attend but that she expects the Theatre Feasibility report today and will forward to the village once she's reviewed.

Mill Street Planting and MAC Highway Adoption.

Fred Woller extended his and the Board's thanks to Boy Scout Troop 80 and other village residents, approximately 20 plus strong turnout, for the Mill Street planting, and thanks to the MAC's Adopt-A-Highway that runs parallel to the Village along New York State Route 28.

Motion made by Ben Fenton; seconded by Fred Woller. All ayed; motion carried.

A discussion by the Board members noting that the December 9, 2019 6:00 pm NYCOM/Wade Beltramo Dissolution Process Presentation and Village Treasurer Winifred Zubin village specific impacts will run long especially as Town of Middletown Supervisor Pat Davis, Council Member Julia Reischel, and DPW/Highway John Biruk are expected to attend for any town related questions.

Chris Yagasits asked about the Emory Brook project at the former Evergreen Hotel. Trustee John Granito answered that it was before the Planning Board and the Village Board can not engage on projects before the Planning Board. It was noted that there is a Public Hearing scheduled for December 2, 2019 at 5:30 pm. Chris thanked the Board and said he would attend then. He also raised the issue of the missing Parking Sign on Main Street near Depot St. Fred Woller answered that the sign had been damaged but that it also was erroneously placed according to the Village Parking Law as it was within the 300 feet allowed by the law.
