The Village of Fleischmanns Board of Trustees held their regular Village Board meeting on Monday, July 8, 2019 at the Skene Memorial Library at 6:05 p.m. Present were: Mayor Fred Woller, Trustee Daniel Halpren, Trustee Larry Reilly, and Trustee Ben Fenton. Trustee John Granito was absent. Also present were Village Deputy Clerk Paula DeSimone and Village Treasurer Winifred Zubin.

## Treasurers report

Treasurers report for the year ended June 30, 2019 was submitted as well as the Pool Project Budget Status. Motion to accept by Ben Fenton, Seconded by Larry Reilly; all ayed, motion carried. Reilly requested a comparison of tax collections compared to prior year.

Reilly reported that closeout paperwork for FEMA project worksheets for the Park have been submitted.

Water and Sewer Report - Jim Buchan was absent.

## Water billing issues - Deputy VC Paula DeSimone and Village Treasurer Winifred Zubin

According to the Paula DeSimone and Winifred Zubin, Paula has been reviewing the water billing system for accuracy and completeness of billing to customers and has identified the following issues

- 1. Many Properties have not been billed consistently in accordance with the Water law adopted in 2016.
- 2. Staff have reviewed accounts going back to 2018 and have found
  - a. Omission of capital maintenance charges
  - b. Omission of water meter rental
  - c. Absence of turn on and turn off fees for seasonal accounts
  - d. The missing charges have been applied for 2018-2019 that and are in excess of \$16,000
  - e. Charges have been applied to the accounts and will be billed in the July 1, 2019 water billing. We expect some residents to be upset.
  - f. The charges were found based on water operator Jim Buchan's completed work orders and review of the charges applied to individual accounts

#### 3. Additional issues

- a. Properties with wells are not accessed capital charges, even though they benefit from fire dept services/hydrants
- b. Properties that have meters removed but obtain water service by bypassing the meter box
- c. Seasonal residents pay for meter rent for 12 months while only occupying for 3 months
- d. Consider billing the fixed charges—annual maintenance and meter rent on the tax bill

Letter to be included in July water billing:

To: Village residents

Your water bills in this cycle may look higher than expected. The office staff are completing the review of the Water Law adopted in 2016. We observe that the rates established in the Law have not been consistently applied.

- All accounts should have been charged a \$31 capital charge each quarter for the maintenance of the system, many accounts were not
- All accounts should have been charged for meter rent for each of 4 quarters, many were not
- All accounts should have been charged for turn on and turn off water service at the curb, and for meter removal and reinstall, where applicable, many were not.

From the village as a whole over 150 charges were mistakenly omitted from the billing accounting for over \$16,000 of unbilled charges on over 50 accounts for services that were rendered. We ask your indulgence in our efforts to put the water system on an even keel, i.e., solvent. Not all accounts were affected. We can provide you with details of the transactions in your water account should you wish further information.

# Seasonal Ice-Skating Rink

Dan Halpren reported that Fleischmanns First requests permission to establish an ice-skating rink in the Village Park on Wagner Avenue. He indicated it would be a temporary fixture, intended for daytime use. Trustees requested details of the plan and to determine from the code enforcement officer if it was allowable in the flood plan and whether permits are needed, what liability exposure would the village have, and what insurance is needed and in what amounts; Who would be the owner-the village or an outside party? The Trustees requested a presentation to the board on a minimal facility with no refrigeration.

## State Funding available from the Forest Service and DEC for firefighting equipment

, Village Clerk.

Reilly reported on an available matching grant with local match of \$3,000 for personal safety firefighting equipment for the fire department. Board requested Fire Department to submit a short proposal including an itemized list of equipment. Mark Project will submit the proposal to the funding source. Motion to approve applying for this grant made by Larry Reilly, seconded by Dan Halpren. All ayed; motion carried.

## **Smart Growth Grant**

This project reflects the next phase of implementation of a comprehensive plan for Park improvements. To date the Park has seen rehabilitation to the baseball/soccer field, a fully accessible, ADA compliant playground (the only one in a 75-mile radius), vehicular access and parking. A new "snack shack" and resurfaced tennis courts. Now, the Village seeks to address the issues of aging and dying deciduous trees while creating a more visually pleasing park environment. This will be accomplished through the removal of the dead and dying trees and replacing them with new growth. In addition, the village seeks to develop a series of perennial gardens complemented by benches and other park like amenities. \$54,250 applied for to NYSDEC

## New Business:

#### Foil request re Sewer rates

Alan White, owner of Two Stones Farm Store at 1060 Main Street submitted a FOIL request letter dated 6/5/2019. Response to the FOIL request was delegated to the Village Clerk and office staff. Existing relevant documents are to be provided when available. The issue of high sewer rates for commercial or mixed-use properties has been widely discussed, and affects all municipalities that have DEC funded Waste Water Treatment plants. The village does not have the ability to influence given the agreements negotiated with NYCDEP years ago. Ben Fenton suggested the village grieve to Catskill Watershed Corporation (CWC) who represented municipalities in these negotiations. Fred Woller to follow up with the CWC attorney.

## **New Fire Dept Member**

Motion made by Larry Reilly; seconded by Ben Fenton to approve Fire Dept Recommendation of New Member Shannon Odell. All ayed; motion carried.

#### **NYMIR Recommendations**

Fred Woller addressed the NYMIR recommendations from their March 2019 site visit which included reviewing the existing Sidewalk Repair Ordinance for liability issues and an after-dark inventory of regulatory and warning signs and locations including reflectivity of the signage. He agreed to complete the signage inventory and to seek input on a date for the Sidewalk Repair Ordinance review.

## **Public Comment**

Fleischmanns First Michelle Sidrane presented framed Founders Day Proclamations noting that 90 media mentions equal approximately \$67,000 in free tourism advertising. Michelle requested new website and hoped a student might be able to spearhead a "dialogue of change". Larry Reilly asked if online or print media mentions? Michelle Sidrane responded that the Parade article was print.

Winifred Zubin provided a Pool Changing Rooms budget and architectural drawings and requested members to review and comment on scope of work being considered.
