September 13, 2021 Village Board Meeting Minutes

The meeting was called to order by Mayor Zubin at 6pm, followed by the pledge of allegiance, roll call, all trustees and Village Clerk present.

Attending in Person: Todd Pascarella, Alan Sidrane, Jon Frank, Vicky Szerko, Gloria Zola-Mulloy, Michele Sidrane, Barbara and Justin Kolb, Marilyn Ringel, Alan Warner, Janet Becker, Vicky Szerko By Zoom: Larry Reilly, Francia Miles.

Additions or Adjustments to the Agenda. Dan Halpren added to Old Business, Law & Order and Mayor Zubin Added to Old Business Ethics Disclosure.

Announcements:

- 1. The Mountain Eagle reported there is funding for the Depot Street Train Station reconstruction. To clarify the reporting, the Village is not funding this project, the Delaware County Planning Dept is funding this project, not the Village of Fleischmanns.
- 2. The Lake Street Road Construction Contract Bids Will be Opened on Sept 23, 2021 with work to follow hopefully in early Spring, due to having to wait for structural parts to be made.
- 3. Diane Rossman was appointed to the position of Village Clerk, and Jason Wadler and Brendan McClean were appointed as Planning Board Members. Brendan as an alternate.
- 4. Motion to Approve August 9, 2021 Trustee Meeting Minutes, made by Barrows, Halpern seconded. All in favor.
- 5. Motion to accept Financial Reports. WWTP, Water and CEO reports made by Halpern, Cohen seconded, All in favor.
- 6. Dan Halpern was concerned with the WWTP and the problem they are having in the Summer with wipes clogging the sewer pipes. His Concern is the village cannot absorb the cost of maintaining the pipes and suggested that they look to taxpayers billing individual property owners.

Old Business:

- 1. Dan Halpren reported that the Sherriff Substation was delayed, but he is working with the corporal to implement a plan.
- 2. The Mayor disclosed that her lawn maintenance firm has hired a village staff member to his crew and so people might see this person on her property from time to time.
- 3. Jennifer Barrows showed a map showing that the village park is in the flood plain so it would be difficult to build there. The siting for a basketball court is difficult since most areas are in the flood plain. She asked for any help or ideas including building a wood platform, approaching the community bank with it
- 4. Ms. Barrows is going to look into planning for a bonfire in the park

5. The hate crime resolution was nixed in favor of developing a position statement about inclusion.

New Business:

- A Zoning Law Amendment to update the Village Flood Damage Prevention Law to name the Village CEO as flood plain administrator and to add section 5.6 Accessory structures was introduced. A Public Hearing Date was set for Tuesday Oct, 12, 2021 preceding the regular Board meeting. Motioned, Cohen, Barrows Seconded. All in favor.
- 2. Fire Dept. recommendation for replacement Pumper Truck. Work on putting it in budget 2022.
- 3. La Cabana has applied for a renewal Liquor License Permit
- 4. It was decided to send out letters of Foreclosure for delinquent property taxes.

Public Comments:

1. Alan Warner spoke before the Board about the need of a constable in the Village to assure fair treatment of all residents. He recommends having a constable sanctioned by Delaware County empowered to enforce local laws.
