- 3. Rob Allison expressed thank you to Jason Wadler who has served long on the Planning Board, and has recently resigned.
- 4. Rob Allison expressed his thanks to Hiram Davis for his dedication to code enforcement for the Village of Fleischmanns as Code Enforcement Officer
- 5. Motion to approve Meeting Minutes May 3, 2021 Maker: Igal Gofman, Seconded John Fronkowiak, All ayes, motion carried.

- Allison introduced the Application for site plan review VFSPR-14 Debra Freedman and Christine Panas to operate a retail store in one of the sections of the buildings at 1109 Main Street Tax map # 287.14-2-3.
- 7. Christine Panas described the project: Specialty Market, café style with specialty teas and coffee, dried fruits and nuts, legumes, light faire for breakfast, lunch and dinner, locally sourced ingredients where possible, price points 3,5,7,9,11; celebrate the building built in 1856, open 8am-10pm all seasons, composting through a fermenting process; regulated by State Agencies Ag & Markets and Weights and Measures; No grease trap.
- 8. It was noted that a separate sign permit is needed, and is not part of the site plan review
- 9. Motion to waive the public hearing for the VFSPR-14 project made by Igal, Gofman, seconded by John Fronkowiak,
