Monthly Regular Meeting of the Village of Fleischmanns Board of Trustees

Mayor Zubin opened the regular board hearing at 6:09 pm Attendance for both public hearings and board meeting, roll call, trustees Barrows, Halpren, Cohen and Village Clerk present.

Attending in Person: Jon Frank, Gloria Zola-Mulloy, Anita Rubin, and Roy Todd, Barbara Kolb & Justin Kolb, John Blish.

Attending via Zoom: Michael Martin, Larry Reilly, Ben Fenton, Demetra NY, Yehuda Israel, Peter Platis

- Announcement: John Hoeko, has been very active in promoting a fish ladder at the former Lake Switzerland Dam and is working with Trout Unlimited and other parties to accomplish this. It is a great accomplishment as it is helping to create resources in the Village of Fleischmanns.
- 2. Motion to approve October 12, 2021 Trustee Meeting Minutes by Jennifer Barrows, seconded by, All in favor.
- 3. Reports: Financial Report October 31, 2021, Water/WWTP, Code Enforcement Motion to accept by Cohen, seconded by Barrows. All in favor.

Old Business:

4. Zoning Review Committee Update - Mayor announced five people picked for the zoning board: Rob Allison, Elizabeth Hughes, Vicky Szerko, Yehuda Israel, and Francia Miles. Two positions remain to be filled.

Motion to accept appointments Halpren, Barrows seconded. All in favor.

New Business:

5. John Blish Request to install a well at 854 Main Street, on the corner of Bridge and Main Street because of the challenges he has faced providing adequate water service to his building. He has asked the Village to provide a variance that would allow him to install the well. John claims the pipe wasn't buried deep enough and is causing the water to freeze. John said that Jim Buchan, Village Water Plant Operator, recommended John dig up and replace the line from his property to the water main at a cost of \$10,000. He went on to assert that having a well would be beneficial to the village because if there was a water main break, he would still have water and could help the village, it could supply the village with 30 gallons of water per minute.

The Mayor reported that the Village WellHead Protection Law of 2009 prohibited the drilling of private wells in the village and that is why Blish is requesting a variance

The Mayor then asked the Board for their input regarding the variance request and Dan Halpren said that it would set a precedence for any villager to put a well on their property, so he didn't like the idea.

The Mayor reported that the Village Water Law establishes that the line from the water main to the property curb box is the responsibility of the property owner.

Anita Rubin asked to speak and said that her neighbor, Deb Matheisen, received a variance for a well and a variance was made for a mikvah. It was subsequently determined that the Matheison property was outside the water district and no variance was needed or issued, and the Mikva variance was issued for religious reasons based on legal findings

The request for a variance was tabled.

- 6. Motion to accept Code Enforcement Officer as Floodplain Administrator made by Cohen, Seconded by Halpren. All were in favor.
- 7. Budget Modifications #1 2022 for the Lake Street flood mitigation project, use of American Rescue Program Act for infrastructure projects, repair of Skene Library building, restructuring of staff positions, the completion of the pool, Hiring of the Code Enforcement Officer, and the Completion of the Kiosk. Motion to Accept modifications made by Barrows, Seconded by Cohen. All in Favor.
- 8. Resolution for an Interfund transfer to Water Fund from General Fund. Motion to transfer and use funds to pay annual serial bond obligation by Halpren, seconded by Barrows. All in Favor.
- 9. The proposal for a Restaurant for the western storefront of the Maxbilt Theater was discussed. To prepare the space for rent the Mayor proposed installing a bathroom, replacing the flooring, fixing the electrical service, walls and ceiling for an amount up to \$10,000. The prospective tenant is willing to pay a portion of these costs and fully pay for the restaurant buildout.

The Mayor is asking for authority to proceed with a lease and to prepare-the space.

Motion to authorize up to \$10,000 to prepare the Maxbilt storefront for rental by Halpren, seconded by Cohen, All Ayes.

Jon Frank asked if the terms and conditions of the lease were finalized. The Mayor said No.

Anita Rubin asked why only a one year lease, Roy Todd asked if the Village Countered with an offer of a three year lease.

10. Resolution to amend Employee Benefit policy to include dental for which employees will pay for.
