5. Approve Prior Minutes
 - a) Motion to approve the minutes from June 12, 2023 made by Trustee Sarabia, seconded by Trustee Cohen. All in favor, motion carries.
 - b) Motion to approve Code enforcement monthly report of permits June 2023 and Financial report June 30, 2023 made by Trustee Sarabia, seconded by Trustee Cohen, all in favor, motion carries.
6. Old Business
 - a) The Mayor informed everyone that he had sent an email out to the company that does repairs for the playground and is just waiting for a response back from them, before moving forward. And that the sugar maples in the park had been replaced.
 - b) The Mayor updated everyone on the tennis courts, everything looks good, pickleball lines are on courts, only thing needed are some pickleball nets.
7. New Business
 - c) The opening of the pool, the pool opened last Tuesday, it will be open to the general public from Tuesday 11 o'clock to six o'clock to Sunday 11 to 6. The fee is Seven dollars a day for adults four dollars for children. We are also going to be renting the pool out after hours. The pool rental hours will be from 6 30pm to 9:00PM. Anyone wanting to rent the pool will need to sign

a waiver, and provide their own licensed lifeguard. This will prevent the village from any liabilities. The rental fees will be \$250.00 for all day Monday or \$100 to rent it after hours from 6:30pm-9:00pm.

Mayor informed village that the board would be working on grants to raise money for the many projects needed in the village and he also talked about the need to fix/replace the guardrails on Lake Street and Switzerland Ave.

Before moving to the Public comments, the Mayor brought up that he would like the village to be one of friendship, not hate. If anyone is threatened or assaulted, their will be charges pressed against them. Hatred will no longer be tolerated in the village.
